There will be a Regular Meeting of Andrews County Commissioners' Court on Tuesday, January 21, 2020, beginning 9:00 A.M. in the Commissioners' Courtroom, Room 107, Andrews County Courthouse, Andrews, Texas. The purpose of this meeting will be to consider the following agenda:
